



RelyOn Facebook Contest

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: The contest is open to those with an active personal Facebook account, and/or RelyOn Credit Union membership.
2. Agreement to Rules: By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements. In addition, you agree to accept the decisions of RelyOn Credit Union as final and binding as it relates to the content of this Campaign.
3. Contest Period: Entries will be accepted online starting May 1, 2019, and end May 31, 2019. All online entries must be received by completion date of the contest.
4. How to Enter: The Contest must be entered by completing the instructions indicated on RelyOn's Facebook page. The personal account from which the participation sustains from will be the individual that is entered to win. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of RelyOn Credit Union.

You may enter only once by liking and following RelyOn Credit Union's Facebook page. You may also submit additional entries by liking posts posted by RelyOn Credit Union in the month of May. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of RelyOn Credit Union.

5. Prizes: There will be two winners drawn. The Winners of the Contest (the "Winners") will receive either a four pack of single day admission tickets to Six Flags Over Texas (value of \$300) or a four pack of Texas Rangers home game tickets (value up to \$250). Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by RelyOn Credit Union. No cash or other prize substitution shall be permitted except at RelyOn Credit Union's discretion.

The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole

responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. 6. Odds: The odds of winning depend on the number of eligible entries received.
7. Winner Selection and Notification: Winners will be selected randomly under the supervision of RelyOn Credit Union. Winners will be notified by Direct Facebook Message shortly following contest completion. RelyOn Credit Union shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information.

If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited, and an alternate Winner selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations.

In such case, RelyOn Credit Union may select the Winners from all eligible entries received prior to and/or after (if appropriate) the action taken by RelyOn Credit Union. RelyOn Credit Union reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions. RelyOn Credit Union has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering.
